**Note:**

1. The fees as approved includes the tuition fee, development fee and all other fees to be charged and recovered from the students studying in the Institutes/Colleges.
2. The Institutes/Colleges shall not be entitled to charge any fees over and above the fees approved by the Fees Regulation Authority.
3. If any Institute/s charge any fees over and above the fees approved by the Authority then the Principal and the Management running the Institute liable for the penal action as contemplated u/s. 20 of the Act of the Maharashtra Unaided Private Professional Educational Institutions (Regulation of Admissions and Fees) Act, 2015 now amended as Maharashtra Unaided Private Professional Educational Institutions (Regulation of Admissions and Fees) (Amendment) Act, 2026 (Mah. Act No. VII of 2026), (hereinafter referred as the 'Amended Act of 2026'), beside the order of refund of excess amount to the concern student/s.
4. The fees as approved for the batch of students admitted during the academic year 2026-2027 shall be applicable throughout the course duration.
5. The Institute/College shall not charge and collect the fees from the students admitted to any course for a period exceeding the academic year. In case the fees is demanded, charged or recovered from the students of the period more than one academic year then such Institute/College is liable for penal action as provided u/s. 20 of the said Amended Act of 2026.



6. No Institute/College shall compel the students to avail the facilities like hostel, mess, transportation and students insurance etc.. If the student opt for any such optional facility/facilities, then Institute/College may charge the reasonable amount for providing such facility/facilities. The expenditure incurred for providing such optional facilities shall not be part of the fees approved nor any expenditure made on such account shall be claimed as admissible expenditure.
7. If the fees approved by the Authority is not acceptable for any Institute/College then such Institute may apply for Review of the decision of the Authority by filing the Review Application specifying therein the grounds on which the Institute/College is seeking Review of the decision. Such application for Review must be filed with the office of Fees Regulation Authority within 15 days from the date of communication of fees approved by the Authority to such Institute/s.
8. The Review Application must be presented with processing fees of Rs. 50,000/- per course. Any applications seeking Review presented beyond the period prescribed for filing of Review Application, and/or without payment of processing fees then such application liable to be rejected.

**Item No.3: Any other subject with the permission of Chair.**

- (i) **To consider the letter of request dated 25/05/2026 received from Vedantaa Institute of Medical Sciences, Palghar running M.D/M.S (P.G) (MBBS1147) course seeking withdrawal of proposals submitted for upward revision of fees and to opt for no upward revision of fees for the academic year 2026-2027.**

“Discussed.

By letter dated 25/05/2026 the Institute has requested the Authority to allow the Institute to withdraw the proposal submitted seeking upward revision of fees for the academic year 2026-2027 in respect of M.D/M.S (P.G) course, for the reason the Review Application filed by the Institute as against the decision of the Authority approving the fees for the academic year 2025-2026 was allowed by the Authority on 03/02/2026. Since the Review Application was not decided the Institute was under legal obligation to submit the proposal before the due date prescribed under the Act as well as specified by the Authority.

Since the Review Application was allowed and fees was revised for the academic year 2025-2026, the Institute has decided to opt for 'no upward revision' of fees for the academic year 2026-2027 and apply the fee structure approved for the academic year 2025-2026 for the immediate next academic year 2026-2027 as contemplated u/s. 14(1)(b) (old Act of 2015) now sec. 14(1)(c) of the Amended Act of 2026.



Considering the reasons assigned and taking into consideration that to opt for no upward revision of fees for immediate next academic year is well within the purview of the Institute and the Review Application was decided on 03/02/2026 it was decided to allow the Institute to withdraw the proposal submitted for determination of fees for the academic year 2026-2027 and opt for no upward revision of fees for the academic year 2026-2027 i.e. to apply the fees structure approved for the academic year 2025-2026 for immediate next academic year i.e. 2026-2027.

Accordingly, the application seeking upward revision of fees filed by the Institute is disposed of as withdrawn and Institute is allowed to opt for 'no upward revision' of fees for the academic year 2026-2027. Accordingly, the fees of the Institute approved for the academic year 2025-2026 in respect of M.D/M.S (P.G) course run by the Institute be notified as fees for the academic year 2026-2027.

Let the follow up action be taken accordingly".
